Fire Brigade

The Fire Brigade is a relatively recent part of Koitiata's history. Extracts following outline where it came from and the expansion, between 1978 and 2001.

1978: Turakina Beach Residents Assn requested via RCC "... portable waterpump and hoses for temporary firefighting purposes until a permanent fire service was established."

1982: "... new shed ... to house equipment for village and forest ... pump, hose, siren, beaters supplied by Forestry, system of calls on siren being arranged, key in glass fronted box beside door... residents offered to make trailer."

1983: "... decided to hold fire drill Saturday for purpose of forming volunteer fire brigade."

1984: "...a trailer chassis was donated ... much time putting a deck on ... now stationed at hall with fire equipment on board for immediate use ... need nine residents to form a Brigade."

1987: "... new Fire Appliance, new Fire Station ... eight willing men in team ... new appliance used in real fire, and ... agree fire team made good save."

1988: "... team consists of twelve men and two ladies, as telephone operators."

2001: "... new fire shed ... built in place of 1987 shed ... to house two fire appliances."

Suggestions by Turakina Beach Residents

At the annual meeting of the Turakina Beach Residents' Association on Sunday, the retiring chairman, Mr Les Anderson, welcomed the county riding member, Mr G I Briant, the Rangitikei County Council clerk, Mr M C Griffiths, and the county overseer, Mr Les Vincent, and a large gathering of about 70 residents.

The meeting passed several proposals for improving conditions at the beach. They included a request for more road restriction signs, such as 50 kph speed limits, and "Drive Carefully - No Footpaths" It was also suggested that street names should be erected.

Following complaints about the discharge of guns in the beach area, the County Clerk, Mr Griffiths, said it was unlawful to discharge or carry a loaded firearm in the confines of the Koitiata Domain, as the beach is known. Steps would be taken to ensure that no misuse of motor vehicles would be permitted in the Domain.

Discussions were held on the purchase of a portable waterpump and hoses for temporary firefighting purposes until a perpermanent fire service was established.

Officers elected were: Chaitman. Mr Joe Davis; secretarytreasurer. Mr Noel Abbott; committee, Messrs Phil Cornish, Jack Tremaine, Brian Bayley.

The new chairman thanked the retiring chairman. Mr Anderson, the retiring secretary, Mrs Mavis Farr, and the committee for their past efforts. He also expressed the hope that closer liaison between the new committee and the County Council would be a benefit to all the residents in the Domitin.

 - (3) Street Names: Streets have been renamed in accordance with the County Council's plan and street name sign posts have been erected.

 - (5) Speed limit Signs: have been erected and in view of no footpaths and many children playing, it is in the interest of all beach residents to observe these.
 - (6) A Public Phone Box was suggested but a definite "NO" reply was received from the Post Office. However, many residents have telephones for use in emergencies.
 - (7) Mr. Griffiths of the County Council made it clear that it is unlawful to discharge or carry a loaded firearm within the confines of the domain.
 - (8) The County Council replied in response to a request for firefighting equipment (namely a pump) that the County was doing a Survey of the area and the matter rould be taken to the Fire Service Commission at a Council level.

CHAIRMANS NEWSLETTER - DECEMBER 1981

On 10 March 1981, the seven nominees for seven positions on the newly formed Koitiata Community Council met. For personal reasons, one nominee withdrew. The remaining six signed the Declaration by Councillors, pursuant to Section 103 of the Local Government Act 1974. The extraordinary vacancy was filled by appointment, of the only late nomination at the July meeting. The seven members are A.J.L. McIndoe, J.M. Richards, D.R. Taylor (Mrs), L.J. Tremaine, M. Burberry (Mrs), N.N. Abbott and B.S. Bayley.

The Community has adopted a set of Bylaws. Each Councillor has a set and the public are entitled to view these on request. Also, all the Councillors are Honorary Rangers. They are all approachable people and will be willing to assist you in any way on request, with information etc.

The Rubbish Dump has reached the end of its useful life and the Council is in the process of hearing objections to the relocating of same just to the north east of the Domain. Hopefully, it will be in use at an early date. We notice that people are reluctant to dump their rubbish in the tip head, thus causing at times quite an unnecessary pile up. With the new tip, we hope everyone will try harder. Also, children use it as a playground. They love smashing enything glass, creating a danger to everyone. Before long someone's child will come home with a badly gashed foot and we are quite a way from a doctor. The remedy is in the parents hands.

Animal carcasses on the river and beach frontage: unfortunately, as long as we have a river outlet and there are farms along that river, we will have this problem. However, in the near future we hope to have material readily available so that this offensive matter can be burned under supervision.

While I am talking burning, we live in a fire restricted area, so if you wish to burn anything, you must obtain a permit to burn from the Forestry Fire Ranger, Mr Noel Abbott. This is important.

The Public Showers and Conveniences on the beach frontage are a target for vandalism quite frequently. A meter miser will be fitted to the showers to give them a timed flow. They will automatically "cut off" if left running. Our thanks must go to Mrs Leighton for her efforts in keeping these conveniences clean and usable and also for looking after the meter boxes at the carayan park. Neither chore being the most relished at times.

Some of you may have noticed a concrete slab on Lot 65 in Wainul Street. By the time you are reading this newsletter, there will probably be a shed erected on this site. This is to house fire fighting equipment for the village and forestry. The initial equipment will be supplied by the Forestry. The Council had hoped to see the building and equipment installed before Christmas. It could possibly still be but more likely to be in the New Year. Of course, equipment will not operate by itself so there will be volunteers called for later to train for fire fighting. But more about this when it is organised.

A meeting of Koitiata Section holders held on 2nd August 1982 supported the constitution of a Community within the Rangitikei County.

A special Order constituting the Koitiata Community was confirmed at a meeting of Rangitikei County Council held on 9th October 1980 and the Community came into being on 1 April 1981.

The Council consists of seven members four representing permanment residents and three representing other property holders.

The Councillors were elected by postal ballot and will hold office until the next local body elections in 1983.

Fire Equipment. A portable pump and hose together with a siren and sets of beaters have been supplied by the Forestry Department. The equipment will be housed in the Hall building. It is Hoped in the near future to get a slight trailer for transporting the equipment in time of emergency. A system of calls by the siren is being arranged by Nr.N.Abbott.

In case of an emengency a key for the Hall will be placed in a glass fronted box beside the side door of the Community building. I understand several residents have offered to help make a trailer and our thanks go to them for their offer.

Covs. The Committee has had continuing discussions with County representative about the dairy covs using the road daily. The Council had a meeting in the Turakina Hall last year with farmers using Beach Hoad with satisfactory results in all but one case -

Hr. Johnston now moves his cows through his own property and they only cross the road in one place.

The County levelled the sides of the road in one area so that the covs could be encouraged to walk on the grass. An employee on a motorbike was going to ride along beside the covs and encourage them to use thegrass verge. This has not been done and an effect the tendency is to let the covs out onto the road and to wander along in their own way.

According to the County an alternative bridge was being prepared to keep the cows off the road bridge. Nothing seems to be happening as yet on this matter. Mr. Vincent the County Overseer assures in that progress is being man to improve the cow situation.

Domain. Camping; grounds. Suggestions have been made to the County that the camping area be moved to a spot adjoining the present conveniences and that the flat area adjoining the conveniences be developed into a recreation area. The suggestion is that the present Domain area then be roaded and subdivided into building sections.

The last demonstration held on 25 September had a disappointing response, if you are interested in forming a fire brigade please attend this meeting.

M. C. Griffiths COUNTY CLERK 8/26 The County Clerk advised that the County would be undertaking the cost of planning and development of the subdivision. No nosting had been done and therefore no accurate estimate on the cost of each section could be given although present indications would put the figure at \$5,000.00. The standard of subdivision would be appropriate to a beach settlement. The subdivision would have some effect on the value of the present properties at Koitata but it would not necessarily have any effect on the rates. In fact, because there will be more rateable properties the rates could be reduced in comparative terms.

"That the Reserve and Camping Ground remain in the same area that they presently occupy and that the staff of the Rangitikel County Council prepare a subdivision for the remaining half of the domain area recently purchased by the Rangitikel County Council."

Resiting of Camping Ground

As the proposed subdivision of the Domain area in which the Camping Ground is presently sited is not going ahead, the Camping Ground will not be resited.

Fire Drill

Ratepayers and Residents expressed concern that no one was trained to operate the fire equipment. Councillor Abbott pointed out that the New Zealand Forest Service gave a practical demonstration on 25 September 1982, and very few residents turned up for the demonstration.

It was decided to hold another fire drill on Saturday, 9 April 1983 atr 9.00 a.m. at the Community Centre for the purpose of forming a volunteer fire brigade and to hold another demonstration, all section holders would be circularised of the time and place.

It was pointed out that several of the vacant sections were overgrown and presented a potential fire hazard.

Councillor Abbott advised that he had devised a system of signals for the fire siren. Short blasts would indicate a fire in the village area and a long continuous wall would signify a Civil Defence or emergency.

OTHER BUSINESS:

Local Body Elections:

The County Clerk advised that the Electoral Roll would be open for public inspection on 17 June 1983. The Election will be held on Saturday, 8 October 1983. Nominations for election would be called on 1 August 1983 and nominations would close at noon on Tuesday, 2 September 1983.

There are seven positions available on the Council, it 7 members are nominated there will be no election. Those nominated will become the Koltiata Community Council. If more than 7 members are nominated an election will be held in the normal manner.

Those eligable to be nominated to the Council are persons with a ratepayer qualification, usually the person shown first on the valuation roll is the ratepayer. This person can reside in the community or outside. A resident can also be nominated for the Council but must actually reside within the Koitiata Community.

Public Toilets

Mrs Leighton has advised that she wishes to discontinue her duties cleaning the public toilets, however, she will continue her duties until a suitable replacement is found. Any person wishing to fill the position should contact the County Overseer.

Roading

Ratepayers and Residents advised that the surface of Rapaki Street was not upgraded satisfactorily and that water was flooding and running into the sewerage systems of nearby properties. The County Overseer advised that the uneven road surface will be corrected in the next financial year when the road is scaled and that the drainage problem will be taken care of at the same time.

Cattle

The ratepayers and residents advised of their concern at the use of the Turakina Beach Road as a cattle race because of the damage to the road and to vehicles using the road.

The County Overseer advised that talks were continuing with the farmer concerned and that a bridge will soon be constructed to remove the congestion on the one-way road bridge.

There being no further business the meeting closed at 11.30 a.m.

- (a) Local Recreation & Community Development Scheme, at the Eangitikei County Council and a grant of \$150 has been received.
- (b) To the Internal Affairs Department through the Local Authorities Community Pacilities Funds.

This application will need to be approved by the Rangitikei County Council.

A representative from the Internal Affairs Department is meeting me in
Turakina on the 31st May and is coming to the Beach to see the project.

- (c) An application has been made to the Dudding Trust in Marton for a grant and I Have been advised that the application will be considered next September.
- Trailer. A trailer chassis to be used to carry the fire fighting equipment was donated by Mr. Sonny Reardon. Councillor McKenzie spent much time putting a deck on the trailer and it is now stationed at the Hall and has all the fire fighting equipment on board ready for immediate use.

Tractor Hower. The County have an old tractor and mover which they are overhauling.

When the work is completed the unit will be stationed at the Beach and will be used primarily to keep the playing area in Te One St. cut. Councillor McKenzie has cut this area with his own motor mover for the past year or so.

Subdivisions. The County is going to cut up a further area to provide 27 sections for building. An earlier proposal was to subdivide the present demain but there were objections to this proposal. In late March a new proposal was made to all section holders and they were asked to make their choice of three options and reply by 30 April:

38 replies were received.

8 section holders preferred the original scheme

25 preferred the scheme to subdivide an area off Teone st. Adjoining the conveniences.

5 had no particular preference.

The suggested subdivisions to be done in three stages will create a new road around the outskirts of the settlement from Vainui St to TeIne St. Rapaki St and Omaku St will be extended to join the new road around the outskirts of the settlement. In the letter of April 1984 Rapaki St was shown as ending short of the new road around the outskirts. Following discussions at the last Community Council meeting it has been decided to continue Rapaki St onto connect with the new road around the outskirts.

The County staff have been surveying the subdivision area and the County hope to commence work on the subdivision during the winter. Anyone interested in getting a section in the subdivision should contact the County.

FOADS. All roads in the settlement were sealed before the end of the 1983/84 sealing season.

In the next few weeks they will be given another seal. The County will widen portions of Rapaki St. before the roads are given the new seal.

COMMUNITY HALL. Since the last newsletter the toilets and kitchen have been completed and painted. The whole kitchen and toilet area is very attractive.

Special thanks must go to Mr. Noel Abbott who painted the whole area - to Messrs Jermy and Cornish who finished the the lining and fitting in of sinks and cupboards, Messrs McKenzie and Ramsdale who were respondible for work on the spetic tank, fitting of pumps and the working of the water system.

The exterior of the building must be painted in the next few weeks. A call is made for volunteers to do this work, contact in the first instance should be made with Alan McKenzie (Phone 855). An early response to this appeal would be appreciated.

We await replies to our applications to various bodies for grants towards the cost of extending the Hall. The suggestion was that the hall should be extended by ten feet. The suggestion has now been made that the extension should be 20 feet rather than 10 feet. This would give the space for improved recreation facilities in the Hall plus an area 20x10 which could be used to house the firefighting equipment plus the County's tractor mower.


FIREFIGHTING. The Community Council wishes to form a Volunteer Fire Brigade in the settlement.

Along the boundary of the property immediately behind the hall a wall of tyres will be made to stop any of the sand fill falling on to the adjoining property. The Council is grateful to Mr.Alan McKenzie for obtaining old tyres to be used for this purpose.

The visitors will be entertained in the Community Hall. This is an Annual visit much appreciated by the elderly people in Marton.

NEW ZEALAND FIRE SERVICES.

As your Chairman, with the big changes taking place at the Forestry Depotwhich is now practically unmanned, I together with the Rangitikei County Council Secretary, Mr Stringfield, wrote to the New Zealand Fire Services explaining our concern at the fire protection of the Community. The New Zealand Fire Services District Fire Officer (Wanganui), Mr Peacock, Regional Fire Officer (Palmerston North), Mr Smith and his Deputy, Mr Christensen, paid the area a visit and with myself made an inspection of the residential area and fire equipment. They explained that our Community can not come under the New Zealand Fire Services because of Marton and Ratana Brigades being so close, but we all agreed we definitely deserved help and they placed us on a priority list for fire gear and a fire appliance, as one became available surplus to their requirements. Since then the gear has arrived and the fire appliance is at Palmerston North awaiting book clearance. The cost for the engine is twenty dollars for Change of Ownership so I hope this appliance will be another asset to the Community. To make use of that asset we will need more people to know how to handle and maintain the machine. The New Zealand Fire Services will put on two one day courses on fire fighting, one in May and one in September. Anybody wishing to attend, please contact me for further information.

BEACH ROAD STOCK.

It gives me great pleasure to thank the Rangitikei County Council for their efforts with the up grading of the Beach Road verges, so that the cows are now driven off the road where possible. A big improvement for us and our cars and, of course, the road.

RUBBISH DUMP.

Over the last two months there has been a big improvement and with a little more thought from everybody by dumping their rubbish over the pit head, the improvement can continue. Also, being a dry dump, if dumping fish or meat etc, take a shovel and dig a hole and make sure it is buried. This means less flies and smell.

Special thanks to Ron Eustace who lately has been giving his time, keeping the dump clean with tractor and blade.

FIRE.

As stated earlier, there was a fire at Mr and Mrs D. Taylor's on the 11 April 1987. Firstly, we now have our own Fire Appliance, a new Fire Station and eight very willing men in our fire team, who give their time and effort to attend practices and are on call for any fire fighting in our area. Our special thanks must go to these men; also Wanganui, Marton and Ratana Fire Services for all their help and support. Our thanks also to the Rangitikei County Council, who maintain the machine. By the way, the applicance has been used at a real fire here, and I am sure the residents all agree the appliance and fire team made a good "save".

To remind everybody, in case of a fire DIAL III or go to the Community Hall where next to the side door is a glass with a key behind. Break the glass, unlock the door and our siren switch is in the storage area just inside the door on the lefthand side (far wall). Turn the switch on and leave on. Stay, if possible, until the first firemen arrives.

Emergency Carpool

Has been used three times since the last report - may I add with success. So this is proving to be a great asset to our Community. Our thanks to drivers and those who helped.

Garage Sale

This proved to be a great success, over \$700 being raised for Community Projects. Many thanks to the organisers, the givers and buyers, and to those who made donations, and of course to all the helpers and Jim Mant for the raffle.

First Project

The electrical wiring of the Fire Station lights and hotpoints etc. This has been completed thanks to Martin Pritchard who did all the labour at no charge. Thanks Martin. We are grateful also to Frank Jerny and his helpers for boxing, digging and levelling and floating the poured concrete for the erection of the firestation. To Trevor Jurgens as well for making up the brackets for the suction hose (he charged for the cost of steel only) and to those who dug the trench for underground power and levelled off the back of the firestation. The Community Council agreed that seeing that so much has been done by Community effort, we will be holding an official opening of the Fire Station on Sal Martin December 1987 at 1.30 p.m. The programme is as follows: Official Opening, inspection of Station and Appliance, and demonstration of fire team. After this, there will be afternoon tea and a few drinks in the Community Hall. All householders are welcome. If you and yours intend coming along, (and we hope you will - and ladies a plate please), ring or contact Noel Abbott or Ray Vicars. This is for catering purposes only.

Civil Defence

The team has been brought back up to fall strength again. Our thanks to the Old Brigade for past services and welcome to our new team members. Firefighters Have New Station at Turakina Beach

Koitiata settlement at Turakina Beach may be small, but it is a closeknit community with great spirit and determin-

The population of 120 permanent residents have banded together to build a new fire station, which was officially opened last Saturday afternoon at Koitiata.

Present at the opening ceremony were Chief Fire Officer Joe Kawana from Ratana Pa, Deputy Chief Fire Officer Paul Hudson from the Marton Volunteer Fire Brigade, and Chief Fire Oficer Ian Connelly from the Bulls Brigade.

Turakina Beach Fire Chief, Mr

Noel Abbott, welcomed guests.
"The building of the fire station has been a wonderful com-munity effort", Mr Abbott said. "The finance from a garage sale in September and our working bees have helped us to finish our new fire station".

Mr Abbott invited the Turakina riding member of the Rangitikei County Council, Cr Tim Lethbridge, to speak on behalf of the Council, and to open the door of the new station.

Cr Lethbridge said: "The fire station is a credit to your community. The facility would not be here unless you had done all the work and raised the money yourselves. "The effort is typical of what you, at Koitiata, have put into all your endeavours. You have this degree of resource-

Cr Lethbridge commented that the close proximity of the Santoft forestry was a good reason to station a fire engine at Turakina Beach.

Benefit to Forestry

"The fact that you have shown responsibility in this area is of benefit to the forestry", said Cr Lethbridge.

The fire party at the beach presently consists of 9 firemen, with prospects of another joining their ranks. Most of the firemen started their service at the same

The firemen are pleased to have the support of the Marton, Wanganui, Ratana and Palmer-ston North Brigades.

After the official opening of the station, firemen gave a demonstration with the Koitiata fire truck, a New Zealand Fire Services vehicle, previously owned by NZ Fire Services at Rangiwahia.

The water supply to fight fires will come from private water tanks, small ponds, or the river at Turakina Beach.

Roll on the long, hot summer — Koitiata's fire crew is ready

Koitiata's rural fire party members are seeing red these days... lots of it.

But it's the cheery red of their two fire appliances now housed, for the first time in a long time, in their own purpose-built "shed".

The new Koitiata Fire Depot, which will be officially opened this afternoon by Rangitikei Mayor John Vickers, is the fifth fire appliance shed at Koitiata since 1985.

The first shed, which was home for the village's original, battered, old Land-Rover fire appliance, ultimately turned into the Koitiata community hall.

And, as that facility was expanded, the fire depot was shifted further along until it ended up at the opposite end from where it started.

And that's where the new shed has been built.

Fire party chief Peter Bamford said the new depot represented a kind of joint venture between the community and its fire party of 12 and the Rangitikei District Council.

The council put up the \$17,000 for the Skyline kitset garage, but it was the fire party members who put it together with advice and assistance from Skyline rep Clayton Grant and some local carpentry expertise.

Mr Bamford said almost 600 voluntary manhours had gone into the project, which also involved the building of a sand-retaining wall along the back and down one side of the new shed.

Timber materials for that — about \$500 worth — were donated by local company Santoft Roundwood.

Earnslaw One forestry company and Jensen Electrical of Marton had also sponsored the project in various ways.

Mr Bamford said that, with the building project now completed, the fire party would be able to get back to its regular training programme to prepare for what he suspects

could be a busy summer.

Koitiata rural fire party is the biggest, most organised and best equipped in the Rangitikei and does duty throughout the district as the second-line fire-fighting unit behind the local New Zealand Fire Service brigades.

Mr Bamford said 20/26summers back the

party was called out 16 times to help deal with some major, potentially serious fires.

Last summer there were a mere two callouts.

But with one call already this season, Mr Bamford reckons his men could spend this summer again eating a lot of smoke.

Rural firefighters blow out 21 candles

Koitiata's finest - the members of the Turakina seaside settlement's volunteer rural fire force - recently marked the unit's first major milestone, its 21st anniversary.

As with all celebrations involving firefighters the orders of the day included the presentation of medals and ribbons signifying varying levels of service. But the gathering also provided an opportunity to members past and present to reflect on the unit's history.

Originally established in November 1982, for the then sole purpose of fighting scrub fires that frequently threatened the village, the Koitiata Volunteer Rural Fire Force has grown up to become a valuable and useful addition to fire-fighting services in the Rangitikei.

The unit has long since shed its "Dad's Army" image to become a committed, competent team called on to deal to foliage fires throughout the Rangitikei and sometimes even in other neighbouring districts.

The unit's initial equipment was a portable pump and hose and a set of "beaters" donated by then New Zealand Forest Service. Over the years the equipment has been progressively upgraded to the point where it now features two well-equipped appliances including a late model four-wheel drive "smoke chaser" with a 500 litre water tank. That has given the unit much greater ability to tackle fires in difficult terrain.

During the past decade the unit has responded to up to 25 call-outs in a season, several of them major propertythreatening blazes as far north as Taihape and as far south as Himitangi.

The Koitiata VRFF has also provided valuable support to other volunteer fire brigades in the southern Rangitikei and regularly assists those brigades in dealing with foliage fires. The increased participation of the Koitiata team has often meant those other fire fighters have been able to return to their employment sooner than would otherwise have been possible
