



Maps

While the word content of the Koitiata History project fills in the detail, it is the graphics that give those words context.

The thirty maps included in this collection span the years from before Koitiata was founded until its current form. They capture in a visual format, the before, the beginning, the shaky start, the eventual establishment, and the growth.

Some of these map files were received from Central Archives in a large file format. They have been cropped and compressed to reduce to a file size suitable for presentation in these pages and the viewing format. Some detail has been degraded in that process.

A page with access to a selection of maps in a high-resolution format has been included. An icon has been provided (27 Hi Res Maps) in the 'subject icon area' below, which links to the page where those maps can be accessed individually for detailed viewing. 
Map of lower Whangaehu and Turakina Valleys

It is applied to Koitiata Stream (at bottom of map), but there is no recording on this map of Lake Koitiata.




Map Illustrating Early History of Rangitikei

Map of Koitiata Survey District



There is no instance of the name Koitiata within the text of "Early History of Rangitikei" by T. W. Downes [source of Maps 1 & 2]

This is the original survey map for the Koitiata Recreation Reserve.

It clearly shows how the seaward reserve boundary follows the inland bank of the river.

There was also a Road Reserve included along the seaward boundary. It still shows on current survey maps.

The river mouth is shown to be quite a distance south of its position on Map 3.



This map clearly shows the road reserves into the town and along the river bank.




Map 6a 1918


This is another copy of the original survey and plan for Koitiata Township.

This is the use of the original survey map and plan for auction of seaside building sites in Koitiata Township.

Interesting to see in bottom section that "copies of lease forms may be seen at the office of the Lethbridge Town Board, Turakina."

The Lethbridge Town Board, established 1876, was the local body which included Turakina township within its boundaries. It merged with Rangitikei County Council in 1925.

So Turakina wasn't there for 49 years!





Because of the Rapaki Street sand drift problem they are all in a cluster around the junction of the Wainui and Omanu streets.






Map of Rapaki street, the short version of Wainui street, and the still unnamed, Omanu Street.

This map shows that the Full House sign was up. Every section has an owner's name marked in this map.

Although the map is dated 1952 it is not known when the names were added. It does indicate that Rapaki street was again considered suitable to be used for buildings.

Copies of RCC documents show that the need for expansion was on the table within a few years of this map's date.

Wainui street was on the horizon.




Plan of 'Environs of Koitiata Domain'


Map 13b 1960's

It is interesting to see that, at the date this was created, that buildings are now shown on all the existing Rapaki and Omanu street sections


Map 13b Koitiata Domain

The existing 'cottages' outside the village are shown on this map. It appears that boundaries have been shaped to fit again.




Wainui Street Extension



Half way down the left edge it shows the right-of-way into the 'bowling-green' sections.





This map includes layout and costings for a bore supplied village water scheme. No other documents have surfaced about this proposal.



This map shows layout of a proposed drainage system.


It is assumed to have been created in response to the flooding of Wainui street in 1970.






Map 25 1984-85 Koitiata




District Planning Scheme Map

This appears to be a civil defence map. There are location symbols for fire brigade and civil defence personal.


Also, all residents' names are marked on map.
