#### **Socialising the Village**

It's not just the organising that has made Koitiata a community, it's the social stuff that does it too. From the beginning, social activities have always been up there at the top of the community's priority list, and what better way to have social activities than with a Social Committee to organise it!

With the new Community Centre upright in 1982, no time was wasted in organising a social function. "Christmas Gathering. In an effort to promote fellowship in the settlement it is suggested that a gathering be held at the Community Building 8pm Saturday 18 December."

The hall became the centre for the community's organised regular activities and there has usually been a Social Committee behind it all. While the hall has been the hub, not all community activities were indoor.

When the river was just out the front, often a wide lagoon would form in front of the village. Some complained about how it restricted their ability to go fishing. Others just had fun having raft races.

A community event during the 1990's was the Xmas parade. People dressed up like clowns. Residents also decorated their tractors and motor bikes and bicycles.

And one of the community activities involved a fire engine which would drive around town while full of Xmas Carol singing ladies.

But one event is a mystery; from a 1985 newsletter "...the group which organised the band function on the Domain a year or so ago ...permission given to organise similar band function on the Labour Day week-end." Phoned Pink Floyd, it wasn't them.

Freeholding of Sections. Application to freehold sections had to be lodged with the Commissioner of Crown Lands before June 15th 1982. Those who made application to freehold their sections will have, or will in the next few days receive a Certificate of Title for their Section.

This is an important document and will need to be produced if the section is sold or a mortgage is raised on the property.

See that it is put away in a safe place and remember where you put it.

Community Centre. The building sited towards the end of Wainui Street, perhaps known as the Fire Station has been officially named as the Community building.

If is available for use by Community groups for meetings or functions. As funds become available the building will be lined and furnished and probably added to. A sink top has been offered to the Council by a resident. Matters being considered for attention are:-

T. Installing of heating points

- Obtaining a tank preferrably 5000 gallons to provide a supply of water for fire fighting and use in the hall.
- Painting the walls and roof
   Doing the necessary plumbing
- 5. Obtaining seats and a small table for the hall

In order that these jobs and others maybe undertaken a fund raising function such as (Nousie) can be organised the Council Feels a separate Committee should be formed.

A note notifying property owners of a meeting to be held on Saturday 4th December at 2pm. For the purpose of electing such a committee is attached to this newsletter.

FUNDS. As a result of the efforts of some of the women in the Community and MesdamesBurberry and Leighton in particular approximately \$300 has already been raised. This money will be used on developing the community building.

Koitiata Community Council People may wonder how this Council came into being. In May 1986 the County Clerk wrote the following letter to the Turakina Beach Residents Committee:- The General purposes of a Community Council are:-

- (a) To co-ordinate and express to the County Council the views of the Community on any matter of concern to the community; and
- (b) After consulting and obtaining the consent of the County Council, to take such action in the interests of the community with respect to any matter of concern to the community as is appropriate, expedient and practicable; and
- (c) To undertake encourage, and co-ordinate activities for the general well being of the residents of the community; and
- (d) To perform such functions and exercise such powers as may from time to to time be delegated to it by the County Council under section 632 of this Act or under any other Act.

Under section 632 of the Act this County Council may delegate to the Community Council any functions which in its opinion could best be handled by the Community Council except for the following:-

(a) The powers under the Public Works Act and the Town and County Planning Act.

(b) Fower yo borrow money, to make a rate, to make Bylaws or to enter into contracts.

(c) The power to own property.

(d) The power to appoint or remove staff.

The Community Council is deemed to be a committee of the County Council.

If the caravan area is left in its present location sooner or later pressure will be put on the Council to provide conveniences in the adjoining area. They could cost up to \$20000. By shifting the camping area nearer the present conveniences this cost would be avoided.

Conveniences. As seems to be a common occurance the building is being dirtied and defaced. The Council would be pleased if anyone seeing any offences being committed would report it to a Councillor.

Notice Board. A notice board has been erected at the corner of Wainui Streets and in a few days a map will be placed in it and will be mark marked to show important spots in the Koitiata settlement.

Animals. Complaints have been made recently of stock being allowed to roam in the settlement and not being provided with sufficient food and water.

Will residents with stock please see that proper care is taken of them. The County By-laws have provision for action to be taken if necessary.

Christmas Gathering. In an effort to promote fellowship in the settlement it is suggested that a gathering be held at the Community Building8 pm Saturday 18 December. Opportunity to discuss this proposal will be taken at the meeting to be held on 4th December next. It could well be an opportunity for the new Committee to organise its first function.

Housie - Cards. Mr. Eddie Ramsdale is keen to organise a housie or card evening possibly in November. The idea is to hold evenings at regular intervals during the summer and to hold functions during the afternoon in the winter period. Housie or cards could be organised dependent of the wishes of those attending.

Mr, Ramsdale offers the following proposals.

Subject to enough interest being shown among local residents it is proposed to hold Housie and card sessions or any other form of recreation at times to suit residents.

A meeting to discuss these ideas will be held in the Community Hall on Sunday 28th October 1984 at 2.30pm.

BUSINESS- To ascertain if there is sufficent interest to warrant holding regular Housie or card sessions.

SUBDIVISION. The Council has finalised the plans for the proposed subdivision of the area adjoining the conveniences. Work will commence about Easter 1985 and the subdivision levelling and roading should be completed during the winter and sections will be available for purchase towards the end of 1985.

CATTLE. We will have to endure the mess made by Mr. Greens cows. A start has been made at providing an alternative bridge for his stock adjoining the road bridge near Scotts road. During the winter girders were laid over the stream. The approaches were graded out and recently metal has been tipped on both sides of the stream. Maybe by the end of this season the bridge will be completed.

GARAGE SALE. A very successful garage sale was held in July and a net sum of about \$370 was raised. Our grateful thanks go to all those who donated items for the sale. A refrigerator donated for the sale was kept and forms part of the furniture at the Hall. Part of the money raised will be used to purchase a reconditioned stove for the Hall and to pay the cost of providing a heavier wiring from the street to the Hall.

GARAGE SALE

It is proposed to hold a further sale towards the end of the year. When you are spring cleaning please keep any surplus items that could go to the sale.

Before moving away from the Hall I must on behalf of all the r residents thank Mr.F.Jermy and his assistants for the work and advice they have given with his whole project. In addition to the Hall the kitchen and conveniences are permaent evidence of the debt we own to Mr.F.Jermy and his band of assistants Bill Cornish, Noel Abbott Ernie Ramsdale and others. Mention must also be made of Alan McKenzie and E.Ramsdale who were responsible for installing the septic tank water pump and water system.

A further application has been made to the Dudding Trust for a grant to help meet the cost of additional electrical wiring and lining of the Hall. Mr. Newman will give Voluntary labour for the wiring.

Subdivision. During July County staff worked on levelling the area beyond the existing conveniences. An area sufficient to provide 19 extra sections and a camping ground has been levelled and at present is over sown with lumpin to hold the ground until sections are sold. Kerbing and provision for underground wiring has still to be done. It is expected that the sections will be available for sale by Christmas. Any persons interested in acquiring a section in the subdivision should get in touch with the County.

Conveniences. A new roof and spouting has been put on the convendences

Roads. Last year the remaining metal roads in the settlement were sealed and a few months later they were given a second seal. It is pleasing to know that all the streets in the settlement have been sealed.

Firefighting. We have a trailer and fire fighting equipment garaged at the Community Hall. A pole has been expected at the back of the building and a siren will be fitted in a few days. The siren will warn all the settlement in the case of an emergency. The Committee wants to form a firefighting group to act in emergencies. Will any interested in joining the group please contact Mr.N.Abbott.

Recreation. Two sections at the back of Mrs Rawcliffes residence in Wainui St, have been purchased by the Committee. It is proposed to use portion of these sections to provide a bowling green. The sections have been cleared of lumpin and it is intended to level them in the near future.

Cattle. The Green cows are always a nuisance on the Beach Road. During the year a race has been built in the Greens Property towards the main road - this will keep the cows off portion of that road. A low level bridge has been started beside the present one way bridge. As soon as sides are put on the new bridge we will be free of cattle using the present one way road bridge.

Cards. Over the summer and autumn some residents have attended card evenings held in the Hall. They have been enjoyable and will probably be revived after the winter. Once the additions to the Hall are completed some indoor bowls evenings will be started. An effort may be made to have some housie evenings too.

Donations. I think it is desireable that a record should be made of donations made towards the Hall project. I list below ones I can think of, not in any particular sequence.

# Grooving in Turakina

The highlight of my
Turakina New Year was
undoubtedly the dance at
the community hall. A
humdinger that went on
into the pre-wee hours —
wee being 1, 2, 3am etc;
pre-wee being the biggest
hour of all, which is 12.

I HAD arrived after the fashionable time, which was about 7.30, and most of the material involved in "ladies a plate" had become just that — plates. The informal rules are that if you want a bench beside the trestles then you're there before 8pm — when you can also get the pikelets, the home-cooked ginger cake, the club sandwiches before they start to curl and the top half of the keg.

After 9 you get the semi-club sandwiches, created by people who haven't been able to work out how many layers were involved, the half of the keg that's left when the bubbles have left also, and those flat squares of dried industrial glue with raisins in them that you'll also be able to get at 10, 11, 12.

And of course you dance. You dance foxtrots, quick-steps, waltzes — all done by spreading the fingers



of your right hand around the bowling ball of hip of your country partner and rocking side-ways while moving backwards round the hall. In fact you can dance polkas, tangos, sambas and rumbas in the same way. To do line dancing you probably just flip your partner open like a mussel shell until she is beside you, and rock on, babe.

You learn much in the intervals between dances; for instance you learn that there are 30 Massey Fergusons at Turakina Beach. In fact you re-learn this information because you learnt it here, on this very occasion last year. From, may I add, the very same person.

The most interesting person I met was Les. Les had lived for some years in my homeland of Buller and had worked in the mines of Denniston. We swapped tales of the bath house — four hundred naked men plotting the revolution at the monthly stop-work meeting — lighting the fire at 5.30 in the morning — with gelignite! (It burns like sugar, but don't drop it!)

Then Les told me he could have been a contender. He'd been a boxer, and a mighty fair one at that. He'd fought three times with Eddie Morrison, a local hero who went to the Empire Games in Cardiff, 1958 and should have won. He wuz robbed, of course.

"We worked on the coalface together, and it was me who found the top of his finger when it got chopped off — cripes like trying to find a flea on a black dog. Anyway I did but they never got it back on; bit dirty I suppose."

Anyway, Les fought Eddie three times — "two of them were exhibition matches, and it was really close. Then we had a real bout and he knocked me out — but not by much!"

Then, said Les, Eddie had gone on to knock out Australian champion Tony Madigan — who himself went on to go the full distance with Cassius Clay. "So if he could give Clay a good go and I could give Eddie a good go, who knows what I might have done in a title chance?"

It was a good night — so good, that we all felt we could have gone on. And we did, elsewhere.

My New Year's resolution was to get fit. So, statistically, was yours. At least 90 percent of us, figures reveal, resolve each year to get fit. Well, I thought I could dedicate the odd column to a "get fit with Peter Hawes" section — like Steve Gurney did recently. So, here goes:

Day one: Now, like me, you probably haven't actually got out of a slow walk in the last twenty-five years. So, take it easy!

Day two: Having taken it easy all day you're probably a bit hung over. So we'll start tomorrow.

Day three: Find a nice level path which is soft underfoot — we don't want RSI of the knee joints — and lean forward until you are in danger of falling on your face.

You will find that one leg or other will pop out in front of you to stop this happening. Still leaning dangerously forward will ensure that the other leg will now do the same, as you pivot over the initial leg. A series of such defensive reactions will now occur. This is known as running.




